





They don't allow any of my friend to enter in my room. They talk back about me to others. I had heard with my own ears. When I was not able to fill water because of my illness they haven't allowed me to switch on the cooler. While last year I have filled water in cooler. Sumran had never filled water in cooler. They don't allow me to study.



in my room, they tell me to go out of room in  
mess or corridors for study. My study had suffered  
due to all this. Due to all this, I am getting stressed  
mental and emotional. My performance in  
exams has gone down. It is not that I don't want  
to speak. I just don't as I don't want to stick  
into such things as I am here to study. My parents  
will also come to talk about this matter. I  
was called yesterday and was told to cooperate.  
I had co-operated but they then also they  
abused me by saying 'Saali'. So I request  
management to look into the matter as early as  
possible. So that I can concentrate in my studies.  
I will be very thankful of you. and I want  
to stay in my same room in cooler room.
