*7.1 action to be taken by the head of the institution by the order of hon. Supreme court:
On receipt of any information concerningAny reported incident of ragging, the head of institution shall immediately determine if a case under the penal laws is made out and if so, proceed to file a first information report (fir), within twenty four hours of receipt of such information or recommendation, with the police and local authorities, under the appropriate penal provisions relating to one or more of the following, namely;
V. Violation of decency and morals through ragging;
VI. Injury to body, causing hurt or grievous hurt;
X. Assault as well as sexual offences or unnatural offences;
XI. Extortion;
XVII. Physical or psychological humiliation;
Note: Enquiry /investigation /disciplinary committee reports etc. Are not acceptable. As per ugc regulations only report of the anti ragging committee is acceptable.

Standard Operating Procedure

2. Shall get the details of International students admitted to BDS/ MDS Courses every year and coordinate with the related departments.
3. Shall sensitize the newly enrolled international students on the existence, functioning and role of the cell and also share with them the mode of contact in case of grievance.
4. Conduct two/three meeting in a year in the presence of the Student Representatives to cater to their grievances.
5. Integrate International Students into the college premises and activities without any obstacles.
6. Address the grievance of International students with respect to Academics, Accommodation, Admission, Evaluation or any other issues during their stay.
7. To provide the Students with information about the local customs, language and civic facilities.

Mode of Contact

Drop boxes have been installed at various places in the campus and hospital to facilitate the students report complaints, grievances as well as their suggestions.

International students are provided with contact numbers of the committee members to facilitate 24/7 assistance in case of emergency and also encouraged to directly contact the Member Secretary in case of grievance.
