AGREEMENT

This AGREEMENT (herein after referred to as "the agreement") executed on this date 12-04-2022 between the institute name LATE SMT. VIDYAWANTI LABHU RAM FOUNDATION FOR SCIENCE RESEARCH & SOCIAL WELFARE Secretary SH. GORAV GUPTA Address H-H GARDEN POWER HOUSE ROAD, SRI GANGANAGAR, 335001 Herein after referred to as "the member" AND E-Tech Projects, Hanumangarh & Sri Ganganagar, a company having registered office at Sri Ganganagar, Rajasthan (Hereinafter referred to as the "company")

(The expression "and the company" wherever they occur in this agreement presents shall unless the Context otherwise admits, also mean and include their respective executors, administrators, Legal representatives and assigns)

The company has setup a centralized Solid Biomedical waste treatment facility for the service to the member of Hanumangarh & Sriganganagar and nearby place. Wherein the member shall be benefited by getting their solid Biomedical waste disposed of properly and it is expedient to have a written instrument of agreement defining principal terms and conditions of the projects.

Whereas:

- A. The Govt. of India, Ministry of Environment and forests formulated and notified the Biomedical waste (Management & Handling) Rules 1998, (herein after referred as Rules of 1998), with effect from 27-07-1998 and thru it made it mandatory for the Biomedical waste generating entities, which includes Nursing Homes, Hospitals, Maternity Homes, Pathology Labs, Blood banks, Clinics, Dispensaries etc, to manage, handle, transport, treat & dispose the Waste in accordance with the provisions of the said Rules of 1998, through a Common Treatment Facility.
- B. The Directorate of urban Administration and Development Jaipur (Rajasthan) invited proposal from experienced private parties for providing a common biomedical waste collection, Reception, storage, transport, treatment and disposal facility for waste generated from different institutions at Hanumangarh & Sriganganagar and nearby places on build own and operate basis. Our company was awarded the work of setting up a Centralized Solid Biomedical waste treatment facility for Hanumangarh & Sriganganagar and nearby places.

NOW, THEREFORE, in consideration of the premises and the mutual covenants, promises, assurances, representations and provisions set forth hereinafter, the parties hereto agree as follows:

1. That the member means private/Govt. Hospital, Nursing Home, Pathology Lab, Blood Bank, Private Medical Practitioners and all other solid bio-medical Waste generating institutions and/or entities having place of business in Hanumangarh, Sriganaganagar & nearby places.
2. That the company would develop a "Centralized bio-medical waste treatment facility" and install required equipment for proper disposal of solid biomedical waste as per Rules of 1998 and amended thereafter after receiving the relevant permissions and authorizations from various departments.
3. That the transportations of the solid bio-medical waste shall be part of the responsibility of the company. The company will transport only the segregated solid biomedical waste from designated storage area of the hospital to the treatment site. The company will make its own arrangements for the transportation of the waste. The waste collection will be done within 48 hours; However, one day off will be kept every week for regular maintenance of vehicles and equipment, hence no deductions could be done for this day off.
4. That the member will have to keep their segregated solid bio-medical waste properly packed and tagged as per guidelines of Rules of 1998 & keep it ready at their designated storage area daily on scheduled time for transportation. The company will not collect the waste if:
 - a) It is kept open.
 - b) It is not segregated
 - c) It is not packed, or
 - d) It is mixed with municipal solid waste or liquid waste.
5. That the member will arrange what so ever, non-chlorinated bags, containers of different Color code, labels, tags etc. required for proper segregating, packing and labeling of their Solid bio-medical waste as laid down in Rules of 1998.
6. That the member will not be responsible for any civil liability arising of transportation, accident or any other event during the disposal of solid bio-medical waste. Pre-transport Hazards & risk thereto if any, shall be on the part of the member & company shall not be liable thereto.
7. This project is for treatment of solid bio-medical waste only. Other type of wastes (such as liquid waste and municipal waste) shall be treated or disposed of by the members at their own arrangements. The company will not be responsible for any liabilities other than treatment of solid bio-medical waste.
8. That the member has to take authorization for bio-medical waste/ any other authorization & consents from various departments for their institution by themselves. The responsibility of the Company will be limited to issuing yearly certificate to the member of the common facility who get their solid biomedical waste treated through the company confirming that their waste has been properly treated & disposal off and after clearing all dues, so that the member may submit it to the concerned departments.
9. That the company will charge the member i.e. "solid bio-medical waste generating institution on the total bed capacity. In case it is found that the hospital is operating with extra bed from what is given in the agreement, the company would charge for the extra bed strength for preceding 90 days from the date of information and may stop providing service to such institutions. In the event the increased dues are not paid in 30 days any increment in the bed capacity is to the company in advance.

10. That the Government of Rajasthan has awarded the work to the company for 30 years from the date of establishment of this plant. Hence, this agreement shall be valid for a period of maximum 5 years and it will be valid up to 20.02.2025 and it can be renewed and extended as per prevailing guidelines by state government.
11. The member expressly agrees and acknowledges that this Common Bio-Medical waste treatment and disposal facility is being set up for their collative use. Therefore, during the initial terms of this agreement, the member agrees that the waste generated at his institution will only be treated and disposed of at this Common Facility in accordance with the terms of this Agreement and that any other facility for this purpose would not be patronized.
12. That the charges for the Biomedical waste disposal will be as under: -

13. That the prevailing rates are subject to rise by 10% w.e.f. 01.03.2025 and the member shall be charged accordingly thereafter as per guidelines issued by the authorities.
14. That billing for hospitals and nursing homes will be for minimum 10 beds.
15. That the company shall raise the bills directly to the member on the predefined rates as mentioned in this agreement. Bills are to be paid by the member through cheque /demand draft/ Cash to the company.
16. That the company shall dispatch to the member their part of bill on or before 5th of every month. The due date for payment by the member shall be 15th day of the month. Failure to pay bill by due date shall attract 10% surcharge every month or part there to.
17. That the company may at its sole discretion suspend the collection of waste from the defaulter member, who has failed to pay the dues for continuous two months after duly informing them 15 days in advance.
18. That the defaulting member may be asked to pay a joining fee equal to One month of their monthly average bill.
19. That the new member joining the facility will be charged on the prevailing rates at the time of Joining the facility. Two-month charges have to be paid by the new member as Security bill charges as security amount.
20. This agreement shall take effect from the date of commissioning of the Common Bio medical Waste treatment facility.
