**PROVISIONAL EXTENSION OF APPROVAL FOR AFFILIATION**

Subsequently, in compliance to the orders of the Hon'ble Supreme Court of dated 1<sup>st</sup> September 2021, AICTE issued the notification/announcement about the affiliations, provisional Extension of Approval for Affiliation (EOAA) is hereby granted to **Surendra Group of Institutions, Sriganaganagar** for a period of one year for the academic session 2021-22 on the basis of documents submitted. The EOAA has been granted for the course of **Engineering and MBA** program of the institute in the University for the affiliation of the academic session 2021-22, and session intake will be accordingly as per Extension of Approval (EOA) issued by the AICTE/COA to the institute. However, to maintain the quality academic standards, University shall inspect the institute in the ongoing academic session.

1.	Affiliated institute shall follow all the mandatory requirements as per prevailing rules and regulations of the AICTE/COA/Government (Central/State), and BTU Act/ Statutes/ Affiliation Regulations to maintain quality education standards.
2.	Affiliated institutes shall follow all the instructions issued from time to time, and ensure to furnish the information's/statistics as per the requirement by the University.
3.	Affiliated institute shall not be indulged in any such activity which directly or indirectly favors illegal commercialization of the education.
4.	As being a registered Society/Trust, the periodical elections for various posts enunciated in the constitution therein must be ensured with transparency and its proceedings shall be kept in your Institute.
5.	In accordance with provisions under section-5, subsection (vii & ix) of Bikaner Technical University, Bikaner, Act no. 29 of 2017, one member will be nominated by the University in the institute's Governing Body. He / She will attend the meeting as and when called.

Further, the EOAA for the academic session of 2021-22 shall be valid subject to the following conditions:

1. One time EOAA granted to the institute shall be revised /withdrawn on the verification of the non-fulfillment of any mandatory requirements as laid down by AICTE/COA/BTU. The same will also be applicable on the verification of any serious complaint against the institute,




